With reference to the Regulation 8 of National Commission for Indian System of Medicine (National Examinations for Indian System of Medicine) Regulation, 2023 vide notification dated 20th December 2023, National Teacher's Eligibility Test (NTET) will be conducted by NCISM designated authority for the post graduates of each discipline of Indian System of Medicine who desire to take up teaching profession from the year 2024 onwards.

In continuation to the circular dated 20.02.2024 in this regard, it is further informed National Teacher's Eligibility Test (NTET-2024-25) will be conducted in the month of July, 2024.
