


- 1. Candidates can apply for NCISM NEET SR UG 2024-2025 through the "Online" mode only.
- 2. Online Application Form may be submitted through the link <a href="https://www.cihts.ac.in/ncismneet/">https://www.cihts.ac.in/ncismneet/</a> available on the designated Institute CIHTS website. The Application Form in any other mode will not be accepted.
- 3. Only one application is to be submitted by a candidate.
- 4. Candidates must read the information brochure and instructions carefully before filling up the form. Candidates must follow the instructions given in the Information brochure and on the designated Institute CIHTS website strictly. Candidates not complying with the instructions shall be summarily disqualified.
- 5. Candidates must ensure that the E-mail Address and Mobile Number provided in the Online Application Form are either their own or Parents/Guardians only as all information/ communication will be sent by the designated Institute CIHTS through e-mail on the registered e-mail address or on registered Mobile Number only.

### INTRODUCTION

### About NCISM and NCISM NEET SR UG:

NATIONAL COMMISSION FOR INDIAN SYSTEM OF MEDICINE NATIONAL ELIGIBILITY-CUM-ENTRANCE TEST (NCISM NEET SR UG 2024-25)

The Ministry of Ayush (MoA), Government of India (GOI) has established the National Commission for Indian System of Medicine (NCISM) which is earlier called Central Council of Indian Medicine (CCIM).

As per sub-section (I), Section 14 of NCISM Act 2020, NEET is mandatory for the admission to undergraduate courses in each of the disciplines of Indian system of Medicine in all medical institutions governed under this act (Indian System of Medicine means Ayurveda, Unani, Siddha and Sowa Rigpa Medical Systems).

And as per the direction of Ministry of AYUSH vide letter No. Y-11030/17/2021-EP-III dated 24.12.2021 and Regulation (5) of National Commission for Indian System of Medicine (National Examinations for Indian System of Medicine) Regulations, 2023, it is decided to conduct a separate NEET for Sowa Rigpa discipline every year at such a place/university through any designated authority where maximum participation for Sowa-Rigpa is expected.

Accordingly, NCISM has designated Central Institute of Higher Tibetan Studies (CIHTS), deemed University, Sarnath, Varanasi, Uttar Pradesh to conduct NCISM-NEET for Sowa-Rigpa UG 2024 for the Academic Session 2024-2025.

### NCISM NEET SR UG - 2024-2025 and Role of CIHTS

The NCISM NEET SR UG – 2024-2025 is going to be conducted by CIHTS as per the Schedule given in the Information at a Glance for admission to Menpa Kachupa (B.S.R.M.S.) Course as per the norms/guidelines/regulations notified by the NCISM.

#### **EXAMINATION SCHEME**

### Syllabus of the Test

As per the Serial no. 8 of the NCISM (National Commission for Indian System of Medicine) Entrance Exam Rules, Regulation & Guidelines of NCISM NEET SR UG 2024-2025, it has mentioned that the Question Paper will be based on Bhoti/Tibetan Grammar, Science and General Knowledge etc in Bhoti/Tibetan language as per the existing practice followed by the Sowa Rigpa Institutes.

### Pattern of the Test

The Test pattern of NCISM NEET SR UG 2024-25 comprises of two Sections;

Section A. consisting of 50 Questions carrying one mark each and Section B. with 25 questions carries two marks.

Note: Unattempt/Unanswered Questions will be given no marks. There shall be no negative marks.

### Cut-off percentage of marks to become eligible

a. The cut off percentage for admission in Sowa-Rigpa B.S.R.M.S. course is fixed as 50 percent for general and 40 percent for OBC and SC/ST category.

### **Declaration of Results**

- a. The results shall be displayed on the website of NCISM, the designated institution, and other Sowa-Rigpa institution
- b. If two or more students' scores same marks in NCISM-NEET-SR-UG, the following criteria's to be considered to decide the ranks:
  - i. Such candidate will be given preference, who has studied Physics, Chemistry & Biology in Class XII
  - ii. Higher individual marks in the order of the subject Biology, Chemistry and Physics
  - iii. Higher Marks/Grades obtained in Class XII
  - iv. Date of Birth. The advantage will be given to the person older in age.

# College option for eligible candidates only.

Successful Candidates shall opt all colleges as per the order of his/her priority (College option I, College option II, College option III, College option IV, College option V, College option VI) and College option VII) in the dropdown menu in the sign in web portal only after obtaining score card.

### The important points to note:

- I. Each MCQs carries 01 (One) mark and all SAQs carries 02 (two) marks.
- II. To answer a question, the candidate has to find, for each question, the correct answer/ best option.
- III. Unanswered/ Unattempt questions will be given no marks.
- IV. A general marking will be done in case of declared ambiguous question/s.

# Mode, language medium & duration of Examination

- ➤ NCISM NEET SR UG 2024-25 is a Pen & Paper-based Test
- > The language medium of question paper is Bhoti/Tibetan
- > The duration of the test would be three (03:00) hours.

### **Examination Centres**

- While filling up the Online Application Form, candidates should select any one of the Seven Convenient exam Centres.
- For their convenience, the candidates may select their own city or for neighbouring cities in their State of Residence only and not for far away cities in other States. The designated Institute CIHTS will not be responsible for any inconvenience due to the incorrect selection of centre by the candidates.

# ELIGIBILITY AND QUALIFICATIONS FOR B.S.R.M.S. COURSE

The candidate shall have passed 10+2 with Science (Physics, Chemistry and Biology) or any other 10+2 equivalent qualifications of other streams recognised by concerned State Government or Central Government education boards and shall have obtained minimum of fifty per cent. marks taken in the case of General category and forty per cent. marks in the cases of the Scheduled Castes, Scheduled Tribes and Other Backward Classes; or
2.	The candidate shall have passed 10+2 or equivalent qualifications with Bhoti language, Buddhist philosophy and logic recognised by State Government or Central Government education boards shall have obtained minimum of fifty per cent. marks taken in the case of General category and forty per cent. marks in the cases of the Scheduled Castes, Scheduled Tribes and Other Backward Classes; or
3.	He/She should attain the age of seventeen years on or before the 31st December of the year of his/her admission in the first year of the undergraduate programme
4.	For foreign student 10+2 or any other 12 <sup>th</sup> standard equivalent qualification certified by the association of Indian Universities (AIU) i.e. Equivalent Certificate from AIU evaluation division.

Reservation Policy for Admission to B.S.R.M.S. Course shall be as per norms.

## Instructions for completing Online Application Form

- 1. The candidate, before filling the application form online, must ensure his eligibility to appear in the test. The candidate is required to go through the Information Brochure carefully and be clear about all requirements with regard to the submission of the Application Form.
- The Candidate should fill in complete correspondence/ permanent address with the pin code, e-mail address and mobile number (own or Parents/Guardian only) for future correspondence.
- 3. Candidates must ensure that mobile numbers and e-mail ID filled in the online Application Form are their own or Parents/Guardian only as CIHTS will communicate through SMS or e-mail on the given mobile number and e-mail ID.

NOTE:

### 5. Medium of Question Paper:

\*The medium of Question paper will be Bhoti/Tibetan Language.

- 6. Only one application should be submitted by a candidate. In case, if a candidate has applied more than once, then his/her latest application shall be considered.
- 7. Candidates are not required to send/ submit a hard copy of the Confirmation Page to the designated Institute CIHTS office. However, the candidates are advised to retain the hard copy of the Confirmation Page.

### Step II: Uploading of scanned images

Candidate's Photograph: to be uploaded in .JPG/.jpeg format

- > Passport size Photograph (size: 25 to 50 KB)
- The photographs must be taken on or after 06.01.2024. Photographs should not be with cap or goggles. The focus needs to be on the face (80% face coverage, ears clearly visible, white background)
- · Spectacles are allowed only if being used regularly.
- · Photoshop, Polaroid and Computer-generated photos are not acceptable.
- Applications not complying with these instructions or with unclear photographs are liable to be rejected.
- Application without photographs shall be rejected.
- The photographs need not be attested. Candidates are advised to keep 1(One) passport size coloured photograph with white backgrounds.
- Candidates may note that if the photographs uploaded are found to be fabricated i.e. de-shaped or seem to be hand-made or computer-made, the application of the candidate will be rejected and the same would be considered as using Unfair Means and the candidate would be dealt with accordingly.

• In case someone else's photographs have been uploaded, the candidature shall be cancelled, and the case will be considered as an Unfair Means Case. Criminal action as per laws of the land shall also be initiated.

Note: Same Passport size photograph is to be used for uploading with Online Application Form and for pasting on Hall Ticket/Admit Card at the Examination Centre / Counselling / Admission. Candidates are reminded to keep 2 to 4 passport size colour photographs with white background for further use, if required.

### Check List for filling the Online Application Form:

The candidates are advised to ensure the following points before submitting the Online Application Forms:

- (i) Whether they fulfil the prescribed eligibility conditions for the Test
- (ii) That they have selected their gender viz. Male/Female/Third Gender correctly.
- (iii) That they have selected their category viz General/OBC / SC/ST correctly.
- (iv) Whether they have kept a Printout of Application Form (Confirmation Page) for their own record.

### **ADMIT CARD**

- ❖ The Admit Card is issued provisionally to the candidates, subject to the fulfilment of the eligibility conditions.
- Hall Ticket/ Admit Card will be sent to the eligible candidates on their registered email.
- No candidate will be allowed to appear at the Examination Centre, on the Date and Timing other than that allotted to him/her in his / her Admit Card.
- The candidates are advised to read the instructions given in this Information Brochure as well as on the Admit Card carefully and follow them scrupulously during the conduct of the examination.

In case of any discrepancy in the particulars of the Hall Ticket/Admit Card and Confirmation Page, the candidate may immediately approach the Help Line between 10:00 am and 5:00 pm. In such cases, candidates would appear in the Examination with the already downloaded Admit Card. However, CIHTS will take necessary action to make corrections in the record later.

- e. No Admit Card shall be issued to the candidates whose Applications are found to be incomplete for any reasons (including indistinct/ doubtful photographs) or who do not fulfil the eligibility criteria for the examination.
- f. Issue of Admit Card, however, shall not necessarily mean acceptance of eligibility which shall be further scrutinized at subsequent stages of the admission process.

### BARRED ITEMS AND EXAM CODE

The candidates will be subjected to extensive and compulsory frisking before entering the Examination Centre. The candidates are not allowed to carry the following items inside the Examination Centre under any circumstances.

- a) Any item like textual material (printed or written), bits of papers, Geometry/Pencil Box, Plastic Pouch, Calculator, Scale, Writing Pad, Pen Drives, Calculator, Log Table, Electronic Pen/Scanner, etc.
- b) Any communication device like Mobile Phone, Bluetooth, Earphones, Microphone, Pager, Health Band, etc.
- c) Other items like Wallet, Goggles, Handbags, Belt, Cap, etc.
- d) Any Watch/Wristwatch, Bracelet, Camera, etc.
- e) Any ornaments/metallic items.
- f) Any food items opened or packed, water bottle, etc.
- g) Any other item which could be used for unfair means, by hiding communication devices like a microchip, camera, Bluetooth device, etc.

No arrangement will be made at the Centres for keeping any articles/items belonging to the candidates.

The candidates wearing articles or objects of faith (customary/ cultural/ religious) should report at the examination centre at least two hours before the last reporting time so that there is enough time for proper frisking without any inconvenience to the candidate while maintaining the sanctity of the examination. If upon screening, it is discovered that any candidate is carrying a suspected device within such item of faith, he/ she may be asked not to take it into the examination hall.

In case any candidate is found in possession of any of the barred items inside the Centre, it will be considered as an Unfair Means case and action will be taken against the candidate in accordance with the relevant provisions.

### Note:

The designated Institute CIHTS believes in the sanctity and fairness of conducting the examination, however, it also believes in the sensitivity involved in frisking (girl) candidates and will issue comprehensive instructions accordingly to the staff and other officials at the Examination Centres. The frisking of the female candidates will be done inside a closed enclosure by a female staff only.

### PARENTS/ GUARDIANS

It is expected that parents/guardians will guide their wards appropriately on the following issues before leaving home for appearing in the NCISM NEET SR UG 2024-25.

The candidate should report the Examination Centre by 9.00 am. Therefore, the candidate shall leave home well in advance taking into consideration various factors such as traffic, location of the Centre and weather conditions, etc.

The candidate will follow all the instructions and maintain discipline in the Examination Hall.

The candidate will not breach any examination rule.

The candidate will not use or promote any Unfair Means during the examination.

In case, the candidate finds another candidate using Unfair means in the examination, the same will be immediately informed to the Invigilators on duty.

The candidate will bring only the following at the Examination Centre:

- Admit Card along with passport size photograph affixed on it;
- Valid Original Identity proof.
