**Subject:- Extension of last date of submission of application/scheme to establish new Ayurveda/Unani/Siddha/Sowa Rigpa Colleges/increase in intake capacity in UG and PG courses and to open new PG courses for the session 2025-2026 – reg.**

Sir/Madam,

It is hereby informed that the date of submission of application/scheme to establish new Ayurveda/Unani/Siddha/Sowa Rigpa Colleges/ increase in intake capacity in UG & PG courses and to open new PG Courses for the academic session 2025-26 **was scheduled from 1<sup>st</sup> July, 2024 to 31<sup>st</sup> July, 2024.** However, Commission is in receipt of various request letters from the State Governments, The Registrars of University, The Secretary/President of various Trusts informing that they are unable to issue/receive No objection certificate/Consent of Affiliation from concerned State Government/University which is an essential document before 31<sup>st</sup> July, 2024.

Therefore, Medical Assessment and Rating Board discussed the same and decided **to extend the date of submission of application/scheme to establish new Ayurveda/Unani/Siddha/Sowa Rigpa Colleges/ increase intake capacity in UG & PG courses and to open new PG Courses till 15th August, 2024 for the academic session 2025-26.**

Hence, any Person/Trust/Institution willing to submit an Application/scheme for the session 2025-26 **may submit their application/scheme till 15th August, 2024** through speed post, addressed to President, Medical Assessment and Rating Board for Indian System of Medicine New Delhi in prescribed format along with the requisite documents as per Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2024.

Further, all necessary documents to be accompanied by depositing the below mentioned non-refundable application fee by way of a demand draft or online payment payable to "The National Commission Fund for Indian System of Medicine":-

- a) **To establish a new medical college** – as specified in the NCISM (Minimum essential standards, assessment and rating for undergraduate Ayurveda colleges and attached teaching hospitals) Regulations, 2024.
