Public Notice

Subject:- Submission of application/scheme to establish Ayurveda Gurukulam/New Ayurveda institution along with the teaching hospital for the academic session 2026-2027 - reg.

Sir/Madam,

It is informed that in exercise of the powers conferred by sub-clauses (h), (i), (j) and (zb) of section 55 of the National Commission for Indian System of Medicine Act, 2020, (14 of 2020) read with regulation 9 of the National Commission for Indian System of Medicine (National Examination for Indian System of Medicine) Regulations 2023, National Commission for Indian System of Medicine (Pre-Ayurveda-Programme for Bachelor of Ayurvedic Medicine and Surgery) Regulations, 2024 are formed by the Commission.

- It is a "Seven and half years Ayurveda- Programme" means a residential graduation programme of two years of Pre-Ayurveda, four and half years of Bachelor of Ayurvedic Medicine and Surgery and one year of compulsory rotatory internship and having provision for admission to under graduate course after tenth class through National Eligibility-cum-Entrance Test for Pre-Ayurveda (NEET-PAP).
- > The institution shall be called Ayurveda Gurukulam and shall be affiliated to the Central Sanskrit University, Janakpuri, New Delhi.

Accordingly, the matter was placed in the 120th Board Meeting of Medical Assessment and Rating Board for Indian System of Medicine, NCISM held on 28.03.2025 and Board discussed the same and decided to fix the time period for submitting the new scheme/application to establish Ayurveda Gurukulam/New Ayurveda institution along with the teaching hospital from 1st July, 2025 to 31st July, 2025 for the Academic session 2026-2027.

Hence, any applicant (trust or society or University or any other body but does not include central Government) willing to establish Ayurveda Gurukulam/New Ayurveda institution along with the teaching hospital fulfilling the pre-requisite and eligibility criteria as mentioned in chapter IV, Regulation 30 laid down in this regulation may submit their application offline till 31st July 2025 through speed post, addressed to the President, Medical Assessment and Rating Board for Indian System of Medicine New Delhi in prescribed format as along with all the requisite documents as mentioned in National Commission for Indian System of Medicine (Pre-Ayurveda-Programme for Bachelor of Ayurvedic Medicine and Surgery) Regulations, 2024.

Applicant fulfilling the pre-requisite and eligibility criteria only shall submit the application/scheme along with all necessary attachments as provided in these Regulation.

Further, all necessary documents to be accompanied by depositing the non-refundable application and processing fee as mentioned in Table-10 of Regulation 31 by way of a demand draft or online payment payable to "The National Commission Fund for Indian System of Medicine" as per the enforced regulation and detail of same is as under-
