Subject:- Extension of last date of submission of Applications/scheme to establish new Ayurveda/Unani/Siddha/Sowa Rigpa Colleges/ increase intake capacity in UG & PG courses and to open new PG Courses for the session 2024-25 - reg.

Sir/Madam,

It is hereby informed that the date of submission of application/scheme to establish new Ayurveda/Unani/Siddha/Sowa Rigpa Colleges/ increase intake capacity in UG & PG courses and to open new PG Courses for the session 2024-25 was **scheduled from 1st August, 2023 to 31st August, 2023 and same was extended from 1st September, 2023 to 15th September, 2023.** However, Commission is still in receipt of various request letters from the State Governments, The Registrars of University, The Secretary/President of various Trust informing that they are unable to issue/receive No objection certificate/Consent of Affiliation from concerned State Government/University which is an essential document.

Therefore, Medical Assessment and Rating Board discussed the same in its **58th Board meeting held on 14.09.2023** and decided to extend the date of submission of application/scheme to establish new Ayurveda/Unani/Siddha/Sowa Rigpa Colleges/ increase intake capacity in UG & PG courses and to open new PG Courses **till 30th September, 2023 for the academic session 2024-25.**

Hence, any Person/Trust/Institution willing to submit an Application/scheme for the session 2024-25 may submit their Application/scheme till **30th September, 2023** through speed post, addressed to President, Medical Assessment and Rating Board for Indian System of Medicine New Delhi in prescribed format along with the requisite documents as per Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019.

Further, all necessary documents to be accompanied by depositing the below mentioned non-refundable application fee by way of a demand draft or online payment payable to "The National Commission Fund for Indian System of Medicine":-

- (a) To establish a medical college - rupees ten lakhs;
- (b) To open a new or higher course of study or training, - rupees five lakhs per course per specialty;
- (c) To increase admission capacity -
 - (i) For under-graduate course-rupees five lakhs;
 - (ii) For post-graduate courses-rupees five lakhs per specialty

- 3) Application/Scheme shall be scrutinized on the basis of eligibility criteria like Application Fee, No Objection Certificate of the State Government and Consent of Affiliation of the University etc. and only eligible applications fulfilling all the criteria will be accepted for further consideration and the ineligible and incomplete applications shall not be accepted and shall be rejected and returned to the Person/Trust/Institution.
