- 2. <u>Regulation of Pay and Other Terms of Deputation:</u> The pay of the selected candidate will be regulated under the provisions laid down by the DOP&T on the subject matter from time to time."
- 3. <u>Period of Deputation:</u> The period of deputation will initially be for one year, subject to extension for a period of three years. The deputation, in any case, will not exceed 5 years.
- 4. <u>Reservation for SC/ST:</u> No provision for reservation exists for the posts to be filled on a deputation basis.
- 5. Applications (in duplicate) in the prescribed proforma (Annexure-I) of the eligible candidates whose services can be spared immediately upon selection, together with the certificate from the Forwarding Authority (in proforma Annexure-II), along with the following documents:
  - a. Integrity certificate;
  - b. List of major/minor penalties imposed, if any, on the official during the last 10 years (if no penalty has been imposed, a 'Nil' certificate should be enclosed);
  - c. Vigilance clearance certificate;
  - d. Attested photocopies of the ACRs for the last five years (2019-20 to 2023-24) (each page attested by an officer not below the rank of an Under Secretary to the Govt. of India).
