**VACANCY CIRCULAR**

**Subject: Filling of Vacancies for the Posts of Deputy Secretary, Under Secretary, Section Officer, Deputy Controller of Examinations, and Assistant Librarian on Deputation Basis in the National Commission for Indian System of Medicine (NCISM), Government of India, New Delhi – A Statutory Body Created Under an Act of Parliament – Inviting Applications.**

The undersigned is directed to state that the National Commission for Indian System of Medicine (a Statutory Body created under an Act of Parliament under the Ministry of Ayush, Government of India) has proposed to fill up the following vacancies on a deputation basis, the details of which, along with their eligibility criteria, are given as follows:



2. Regulation of Pay and Other Terms of Deputation: The pay of the selected candidate will be regulated under the provisions laid down by the DOP&T on the subject matter from time to time."
3. Period of Deputation: The period of deputation will initially be for one year, subject to extension for a period of three years. The deputation, in any case, will not exceed 5 years.
4. Reservation for SC/ST: No provision for reservation exists for the posts to be filled on a deputation basis.
5. Applications (in duplicate) in the prescribed proforma (Annexure-I) of the eligible candidates whose services can be spared immediately upon selection, together with the certificate from the Forwarding Authority (in proforma Annexure-II), along with the following documents:
  - a. Integrity certificate;
  - b. List of major/minor penalties imposed, if any, on the official during the last 10 years (if no penalty has been imposed, a 'Nil' certificate should be enclosed);
  - c. Vigilance clearance certificate;
  - d. Attested photocopies of the ACRs for the last five years (2019-20 to 2023-24) (each page attested by an officer not below the rank of an Under Secretary to the Govt. of India).

The applications, along with relevant documents in support of qualifications and experience, etc., may be forwarded to the Secretary, National Commission for Indian System of Medicine, Plot No. T-19, Block IV, Dhanwantri Bhawan, Road No. 66, Punjabi Bagh West, New Delhi-110026, within Thirty (30) days of the publication of this circular in the Employment News/Rozgar Samachar. Applications not forwarded through the proper channel or those received without the requisite certificates and necessary documents will not be entertained. Candidates who apply for the post will not be allowed to withdraw their candidature subsequently.
